- The site is examined to see if it engages in annoying practices, such as excessive popups, fraudulent practices, and browser exploits. Registration forms are completed using a onetime use email address to track the volume and spam content of subsequent emails.
- Then, to see how strongly the site relates to other sites that our tests flag as red, the website's affiliations are also analyzed
